

Joint Order No. 1/2026 (V.19) of the Rector and the CEO**ON THE AMOUNT OF THE SELF-FUNDED TUITION FEE AND OTHER FEES PAYABLE FROM THE ACADEMIC YEAR 2023/2024 AT THE MOHOLY-NAGY UNIVERSITY OF ART AND DESIGN BUDAPEST**

In accordance with the applicable resolutions of the Senate of the Moholy-Nagy University of Art and Design Budapest (hereinafter as: MOME or the University), adopted pursuant to the authorisation set out in Section 24(4) of the University's Payment and Benefit Policy, the Rector and the Chief Executive Officer of the University hereby publish the amounts of self-funded tuition fee and other fees as follows.

Amounts of the self-funded tuition fee and other fees
Section 1

(1) Self-funded tuition fee for bachelor's degree programmes:

a) All degree programmes (except Art and Design Theory BA)	HUF 800,000 / semester
b) Art and Design Theory BA	HUF 500,000 / semester

(2) Self-funded tuition fee for master's degree programmes:

a) All Hungarian-language MA degree programmes (with the exception set out in points b) to c) of this paragraph)	HUF 950,000 / semester
b) Design Theory MA and Art and Design Management MA (in Hungarian)	HUF 600,000 / semester
c) Design and Visual Arts MA degree programme (in Hungarian)	HUF 400,000 / semester
d) MA degree programmes in foreign language (English)	
i. For students who are nationals of an EU Member State or an EEA country, including Hungarian nationals.	HUF 1,200,000 / semester or EUR 3,000 / semester
ii. For students from countries outside the EU or EEA	EUR 5,000 / semester

(3) Fees payable by foreign students who are not nationals of an EEA country:

All BA and MA degree programmes, except for the cases specified in point (d) of paragraph (2) of Section 1	EUR 10,000 / semester

(4) The basic fee payable by students participating in foreign language partial studies:

a) unless otherwise provided by a special law or convention	EUR 2,000 / semester
b) any additional course	EUR 5,000 / semester
c) but not more than	EUR 10,000 / semester

(The basic fee includes the full administrative costs and three courses.)

(5) Self-funded tuition fee for postgraduate programmes

a) Service Design	HUF 750,000 / semester
b) Cultural and museum management	HUF 310,000 / semester
c) Sound Design	HUF 790,000 / semester

(6) Self-funded tuition fee for doctoral programmes:

a) for both PhD and DLA students from Hungary and equivalent EEA countries	HUF 300,000 / semester
b) for students from non-EEA countries	HUF 700,000 / semester
c) cost of the doctoral procedure for doctoral programmes starting before September 2016	HUF 150,000

(7) In the case of a student of another institute of higher education, the fee for cross-enrolment in a Hungarian-language programme:

a) in the case of bachelor's and master's degree programmes forming part of the General Theoretical Studies curriculum or offered by the Centre for Design Culture and Art Studies	HUF 8,000 /subject/month
b) in the case of bachelor's and master's degree programmes not forming part of the General Theoretical Studies curriculum or not delivered by the Centre for Design Culture and Art Studies:	HUF 30,000 /subject/month

Final and transitional provisions Section 2

- (1) Taking into account resolutions Nos. 25-28_2022/2023. (XI.28.), 55_2022/2023. (II.27.), and 78_2022/2023. (VI.9.) of the Senate of the Moholy-Nagy University of Art and Design, this order shall enter into force on the first day of the 2023/2024 academic year, subject to the exception set out in paragraphs (3)–(7) of this Section. Its provisions shall, likewise subject to the exception set out in paragraphs (3)–(7) of this Section, apply in a phasing-out basis to students commencing their studies in September 2023 and thereafter.
- (2) Simultaneously with the entry into force of this order, the Joint Order No. 13/2022. (XI.30.) issued by the Rector and the Chief Executive Officer on the amounts of the self-funded tuition fee and other fees payable at the Moholy-Nagy University of Art and Design from the 2023/2024 academic year shall be repealed.
- (3) Pursuant to the resolution of the Senate of the Moholy-Nagy University of Art and Design No. 6_2025/2026 (X.27.), point d) of paragraph (2) of Section 1 of this order shall enter into force on the first day of the academic year 2026/2027, with the proviso that this provision will be applied for the first time to students starting their studies in September 2026.
- (4) The self-funded tuition fee of the foreign language (English) programmes for students starting their studies in September 2023, September 2024 and September 2025, based on resolution No. 25- 28_2022/2023. (XI.28.) of the Senate of the Moholy-Nagy University of Art and Design, will be as follows:

a) Foreign language (English) programmes in MA degree programmes	
i. For Hungarian students	HUF 2,000,000 / semester
ii. For students who are nationals of an EU Member State or an EEA country, as well as students who are not Hungarian, EU or EEA nationals, but are nationals of another European state	EUR 5,000 / semester
iii. For non-European citizens	EUR 12,000 / semester

- (5) Pursuant to the resolution of the Senate of the Moholy-Nagy University of Art and Design No. 4_2024/2025. (IX.30.), point b) of paragraph (5) of Section I of this order shall enter into force on the first day of the academic year 2024/2025, with the proviso that this provision will be applied for the first time to students starting their studies in September 2024.
- (6) The self-funded tuition fee of the postgraduate programmes Cultural Management and Museum Management shall be HUF 280,000 / semester for students starting their studies in September 2023, according to the resolution of the Senate of the Moholy-Nagy University of Art and Design No. 78_2022/2023. (VI.9.).
- (7) Pursuant to the resolution of the Senate of the Moholy-Nagy University of Art and Design No. 91_2024/2025. (VI.30.), point c) of paragraph (5) of Section I of this order shall enter into force on the first day of the academic year 2025/2026, with the proviso that this provision will be applied for the first time to students starting their studies in September 2025.
- (8) The provisions of this order shall be in force indefinitely, until revoked.
